

Cushing® Renaissance Fund Announces Monthly Distribution

Dallas, TX: The Cushing® Renaissance Fund (NYSE: SZC) declared a distribution for November 2017 of \$0.1367 per common share. The Fund's distribution will be payable on November 30, 2017 to shareholders of record on November 16, 2017. The ex-date for the Fund's distribution is November 15, 2017.

It is anticipated but not certain that approximately 85% of the Fund's distribution will be treated as a return of capital. The final determination of such amounts will be made and reported to shareholders in early 2018, after the end of the calendar year when the Fund determines its earnings and profits for the year. The final tax status of the distribution may differ substantially from this preliminary information.

The Fund is a non-diversified, closed-end management investment company with an investment objective of seeking a high total return with an emphasis on current income. The Fund seeks to provide shareholders with a vehicle to invest in an actively managed portfolio of companies that may benefit from the developing U.S. energy, industrial and manufacturing renaissance. The Fund is traded on the New York Stock Exchange under the symbol "SZC."

The Fund is managed by Cushing® Asset Management, LP ("Cushing"). No assurance can be given that the Fund's investment objectives will be achieved.
